### Scope and Approach

CMA had issued ICAAP compliance requirements for Authorized Persons. The guidelines left room for APs to interpret and implement the same based on their size and complexity. As the guidelines were newly introduced, the APs faced challenges in understanding, developing and implementing the same. Moreover, the deadlines for implementation coincided with ICAAP submissions of their banking counterparts adding to the implementation challenge.

Aptivaa was mandated to provide support, given its prior ICAAP experience along with an understanding of the APs businesses. The Aptivaa team was able to leverage its experience to identify key issues and risks faced by different APs based on their varying businesses and operations, and provided different assessment frameworks based on their size and complexity.
